KRONOS WORLDWIDE REPORTS FIRST QUARTER 2022 RESULTS

DALLAS, TEXAS...May 4, 2022... Kronos Worldwide, Inc. (NYSE:KRO) today reported net income of \$57.5 million, or \$.50 per share, in the first quarter of 2022 compared to \$19.6 million, or \$.17 per share, in the first quarter of 2021. We reported higher net income in the first quarter of 2022 as compared to the first quarter of 2021 primarily due to higher income from operations resulting from the net effects of higher average TiO₂ selling prices, higher sales volumes, higher production costs and changes in currency exchange rates, as discussed below.

Net sales of \$562.9 million in the first quarter of 2022 were \$97.9 million, or 21%, higher than in the first quarter of 2021. Net sales increased in the first quarter of 2022 compared to the same period in 2021 primarily due to higher average TiO₂ selling prices and higher sales volumes. TiO₂ sales volumes were 2% higher in the first quarter of 2022 as compared to the first quarter of 2021 due to the effects of continuing high demand and improvements in our delivery and distribution networks in 2022. Average TiO₂ selling prices were 24% higher in the first quarter of 2022 as compared to the first quarter of 2021. Average TiO₂ selling prices at the end of the first quarter of 2022 were 7% higher than the end of 2021. Fluctuations in currency exchange rates (primarily the euro) also affected net sales comparisons, decreasing net sales by approximately \$22 million in the first quarter of 2022, as compared to the first quarter of 2021. The table at the end of this press release shows how each of these items impacted net sales.

Our TiO₂ segment profit (see description of non-GAAP information below) in the first quarter of 2022 was \$86.8 million as compared to \$38.1 million in the first quarter of 2021. Segment profit increased in the first quarter of 2022 as compared to the first quarter of 2021 primarily due to higher average TiO₂ selling prices and higher sales volumes, partially offset by higher production costs, including raw material and energy costs. TiO₂ production volumes were 6% higher in the first quarter of 2022 compared to the first quarter of 2021. We operated our production facilities at full practical capacity in the first quarter of 2022 compared to 97% in the first quarter of 2021. Fluctuations in currency exchange rates (primarily the euro) decreased income from operations approximately \$5 million in the first quarter of 2022 as compared to the first quarter of 2021.

Our net income before interest expense, income taxes and depreciation and amortization expense (EBITDA) (see description of non-GAAP information below) in the first quarter of 2022 was \$93.2 million compared to EBITDA of \$43.3 million in the first quarter of 2021.

- General global economic and political conditions that harm the worldwide economy, disrupt our supply chain, increase material and energy costs or reduce demand or perceived demand for our TiO₂ products or impair our ability to operate our facilities (including changes in the level of gross domestic product in various regions of the world, natural disasters, terrorist acts, global conflicts and public health crises such as COVID-19)
- Competitive products and substitute products
- Customer and competitor strategies
- Potential consolidation of our competitors
- Potential consolidation of our customers
- The impact of pricing and production decisions
- Competitive technology positions
- Potential difficulties in upgrading or implementing accounting and manufacturing software systems
- The introduction of trade barriers or trade disputes
- Fluctuations in currency exchange rates (such as changes in the exchange rate between the U.S. dollar and each of the euro, the Norwegian krone and the Canadian dollar and between the euro and the Norwegian krone), or possible disruptions to our business resulting from uncertainties associated with the euro or other currencies
- Operating interruptions (including, but not limited to, labor disputes, leaks, natural disasters, fires, explosions, unscheduled or unplanned downtime, transportation interruptions, cyber-attacks and public health crises such as COVID-19)
- Our ability to renew or refinance credit facilities
- Potential increases in interest rates
- Our ability to maintain sufficient liquidity
- The ultimate outcome of income tax audits, tax settlement initiatives or other tax matters, including future tax reform
- Our ability to utilize income tax attributes, the benefits of which may or may not have been recognized under the more-likely-than-not recognition criteria

- Environmental matters (such as those requiring compliance with emission and discharge standards for existing and new facilities)
- Government laws and regulations and possible changes therein including new environmental health and safety regulations (such as those seeking to limit or classify TiO₂ or its use)
- Possible future litigation.

Should one or more of these risks materialize (or the consequences of such a development worsen), or should the underlying assumptions prove incorrect, actual results could differ materially from those forecasted or expected. In an effort to provide investors with additional information regarding the Company's results of operations as determined by accounting principles generally accepted in the United States of America (GAAP), the Company has disclosed certain non-GAAP information which the Company believes provides useful information to investors:

- The Company discloses segment profit, which is used by the Company's management to assess the performance of the Company's TiO₂ operations. The Company believes disclosure of segment profit provides useful information to investors because it allows investors to analyze the performance of the Company's TiO₂ operations in the same way that the Company's management assesses performance. The Company defines segment profit as net income before income tax expense and certain general corporate items. These general corporate items include corporate expense and the components of other income (expense) except for trade interest income; and
- The Company discloses EBITDA, which is also used by the Company's management to assess the performance of the Company's TiO₂ operations. The Company believes disclosure of EBITDA provides useful information to investors because it allows investors to analyze the performance of the Company's TiO₂ operations in the same way that the Company's management assesses performance. The Company defines EBITDA as net income before interest expense, income taxes and depreciation and amortization expense.
