CRANBURY, NEW JERSEY – November 15, 2010 – Kronos Worldwide, Inc. (NYSE: KRO) today announced a price increase for all titanium dioxide products sold outside of North America and Europe including among other areas, Asia Pacific, Latin America, Middle East, Africa and Asia.
