("NL") and Kronos Worldwide, Inc., the issuer and a subsidiary of NL ("KWI"), NL distributed on December 8, 2003 one share of common stock of KWI for every two shares of NL common stock outstanding as of the close of business on November 17, 2003, the record date for the distribution. In the aggregate, NL distributed 23,822,042 shares of KWI common stock to holders of NL common stock in the distribution.
