Valhi, Inc. ("Valhi"), NL Industries, Inc. ("NL") and TIMET Finance Management Company ("TFMC") are the holders of 59.2%, 35.9% and 0.1%, respectively, of the outstanding common stock of Valhi. Valhi Holding Company ("VHC"), Harold C. Simmons' spouse, The Commonwealth Foundation and the CMRT are the direct holders of approximately 83.1% and 0.5%, respectively, of the outstanding common stock of NL. VHC, TFMC, the Foundation and the CMRT are the direct holders of approximately 100%, 0.2%, 0.9% and 8.5%, respectively, of the outstanding common stock of TIMET. Substantially all of Contran's outstanding voting stock is held by trusts established for the benefit of certain children and grandchildren of Harold C. Simmons (the "Trusts"). Harold C. Simmons is the chairman of the board and chief executive officer of each of the issuer and NL and the chairman of the board of each of Valhi, TIMET, VHC, the Foundation and the CMRT. The Foundation directly holds approximately 0.2% of the outstanding shares of TIMET common stock and 0.9% of the outstanding shares of Valhi common stock. The Foundation also holds approximately 0.1% of the outstanding shares of NL common stock. The CMRT directly holds approximately 8.5% of the outstanding shares of TIMET common stock and 0.1% of the outstanding shares of Valhi common stock. Contran sponsors the Trusts. By virtue of the holding of the offices, the stock ownership and his services as trustee, all as described above, (a) Harold C. Simmons may be deemed to control such of the issuer and NL. Harold C. Simmons' spouse is the direct owner of 49,856 shares of Common Stock, 269,775 shares of NL common stock, 21,825,875 shares of TIMET common stock and 200,000 shares of Valhi common stock. Harold C. Simmons directly holds 152,867 shares of Common Stock, 880,600 shares of NL common stock, 7,275,239 shares of TIMET common stock and 4,383 shares of Valhi common stock. A trust, of which Harold C. Simmons and his spouse are trustees and the beneficiaries are the grandchildren of his spouse, is the direct holder of 17,432 of TIMET common stock. NL and a subsidiary of NL directly own 3,522,967 and 1,186,200 shares of Valhi common stock, respectively. Pursuant to Delaware law, Valhi treats the shares of Valhi common stock owned by the Trusts as if they were owned by Harold C. Simmons.
