KRONOS WORLDWIDE REPORTS FIRST QUARTER 2021 RESULTS

DALLAS, TEXAS...May 5, 2021... Kronos Worldwide, Inc. (NYSE:KRO) today reported net income of \$19.6 million, or \$.17 per share, in the first quarter of 2021 compared to net income of \$27.0 million, or \$.23 per share, in the first quarter of 2020. Net income in the first quarter of 2021 was lower than in the first quarter of 2020 primarily due to lower income from operations resulting from the net effects of changes in currency exchange rates, higher sales volumes, lower production costs and slightly lower average TiO₂ selling prices, as discussed below.

Net sales of \$465.0 million in the first quarter of 2021 were \$44.0 million, or 10% higher than in the first quarter of 2020 primarily due to higher sales volumes partially offset by lower average TiO₂ selling prices. TiO₂ sales volumes were 3% higher in the first quarter of 2021 as compared to the first quarter of 2020 primarily due to higher demand in our North American and Latin American markets, partially offset by lower demand in our European market. Average TiO₂ selling prices were 1% lower in the first quarter of 2021 as compared to the first quarter of 2020. Average TiO₂ selling prices at the end of the first quarter of 2021 were 1% higher than our average TiO₂ selling prices at the end of 2020. Fluctuations in currency exchange rates (primarily the euro) also affected net sales comparisons, increasing net sales by approximately \$20 million in the first quarter of 2021 compared to the first quarter of 2020. The table at the end of this press release shows how each of these items impacted net sales.

Our TiO₂ segment profit (see description of non-GAAP information below) in the first quarter of 2021 was \$38.1 million as compared to \$47.2 million in the first quarter of 2020. Segment profit decreased in the first quarter of 2021 compared to the first quarter of 2020 primarily due to lower income from operations resulting from the net effects of fluctuations in currency exchange rates, which decreased segment profit by approximately \$16 million in the first quarter 2021 as compared to the first quarter of 2020, lower average TiO₂ selling prices, higher sales volumes and lower production costs. Due to the phase-out of sulfate production at one of our facilities in the fourth quarter of 2020, Kronos' TiO₂ production volumes were 1% lower in the first quarter of 2021 as compared to the first quarter of 2020. We operated our production facilities at overall average capacity utilization rates of 97% and 95% in the first quarters of 2021 and 2020, respectively.

Our net income before interest expense, income taxes and depreciation and amortization expense (EBITDA) (see description of non-GAAP information below) in the first quarter of 2021 was \$43.3 million compared to EBITDA of \$54.9 million in the first quarter of 2020.

Other income (expense) in the first quarter of 2020 includes a pre-tax insurance settlement gain of \$1.5 million (\$1.2 million, or \$.01 per share, net of income tax expense) related to a property damage claim.

- Competitive products and substitute products
- Customer and competitor strategies
- Potential consolidation of our competitors
- Potential consolidation of our customers
- The impact of pricing and production decisions
- Competitive technology positions
- Potential difficulties in upgrading or implementing accounting and manufacturing software systems
- The introduction of trade barriers or trade disputes
- Fluctuations in currency exchange rates (such as changes in the exchange rate between the U.S. dollar and each of the euro, the Norwegian krone and the Canadian dollar and between the euro and the Norwegian krone), or possible disruptions to our business resulting from uncertainties associated with the euro or other currencies
- Operating interruptions (including, but not limited to, labor disputes, leaks, natural disasters, fires, explosions, unscheduled or unplanned downtime, transportation interruptions, cyber-attacks and public health crises such as COVID-19)
- Our ability to renew or refinance credit facilities
- Our ability to maintain sufficient liquidity
- The ultimate outcome of income tax audits, tax settlement initiatives or other tax matters, including future tax reform
- Our ability to utilize income tax attributes, the benefits of which may or may not have been recognized under the more-likely-than-not recognition criteria
- Environmental matters (such as those requiring compliance with emission and discharge standards for existing and new facilities)
- Government laws and regulations and possible changes therein including new environmental health and safety regulations (such as those seeking to limit or classify TiO₂ or its use)
- Possible future litigation.

In an effort to provide investors with additional information regarding the Company's results of operations as determined by accounting principles generally accepted in the United States of America (GAAP), the Company has disclosed certain non-GAAP information which the Company believes provides useful information to investors:

- The Company discloses segment profit, which is used by the Company's management to assess the performance of the Company's TiO₂ operations. The Company believes disclosure of segment profit provides useful information to investors because it allows investors to analyze the performance of the Company's TiO₂ operations in the same way that the Company's management assesses performance. The Company defines segment profit as net income before income tax expense and certain general corporate items. These general corporate items include corporate expense and the components of other income (expense) except for trade interest income; and
- The Company discloses EBITDA, which is also used by the Company's management to assess the performance of the Company's TiO₂ operations. The Company believes disclosure of EBITDA provides useful information to investors because it allows investors to analyze the performance of the Company's TiO₂ operations in the same way that the Company's management assesses performance. The Company defines EBITDA as net income before interest expense, income taxes and depreciation and amortization expense.
