Valhi, Inc. ("Valhi"), NL Industries, Inc. ("NL"), Harold C. Simmons, TIMET Finance Management Company ("TFMC") and Harold C. Simmons' spouse are the holders of Titanium Metals Corporation ("TIMET") directly owns 100% of the outstanding common stock of TFMC. Valhi Holding Company ("VHC"), Harold C. Simmons' spouse, The Valhi and TFMC are the direct holders of approximately 83.1% and 0.5%, respectively, of the outstanding common stock of NL. VHC, TFMC, the Foundation, Harold C Substantially all of Contran's outstanding voting stock is held by trusts established for the benefit of certain children and grandchildren of Harold C. Simmons Harold C. Simmons is the chairman of the board of each of the issuer, Valhi, TIMET, VHC, Dixie Rice and Contran and chairman of the board and chief executive of The Foundation directly holds approximately 0.2% of the outstanding shares of TIMET common stock and 0.9% of the outstanding shares of Valhi common stock. Contran spt The CMRT directly holds approximately 8.5% of the outstanding shares of TIMET common stock and 0.1% of the outstanding shares of Valhi common stock. Contran spt By virtue of the holding of the offices, the stock ownership and his services as trustee, all as described above, (a) Harold C. Simmons may be deemed to control Harold C.
